

Terms & Conditions:

1. "Offer": 50% cashback on Movie tickets (across all cinemas in UAE).
2. Eligible Card holders: Finance House PJSC ("FH") Credit Cards & Cartnet Credit Cards (collectively referred to as "Credit Card").
3. Campaign Period: 1st September 2019 to 30th August 2020.
4. 50% movie cashback or AED 100 per month (maximum cashback capped at AED 100 per month), whichever is lower.
5. Minimum monthly retail spends threshold of AED 3,000 on the Credit Card is required to avail the Offer.
6. Based on customer's minimum spend eligibility, movie cashback will automatically be credited to their respective Credit Card statement.
7. Customer will be required to purchase the movie ticket in full from the theatre's counter.
8. Offer valid only for regular or 2D tickets with standard seating only. 3D, 4D, Premium, VIP, etc. are not eligible for this Offer.
9. Maximum Offer cap per month: AED 100
 - a. Example 1: standard movie ticket will cost the customer AED 40.25 (approx.), if customer buys 4 movie tickets then customer has to pay AED $40.25 \times 4 =$ AED 161 to the cinema operator). 50% cashback will be calculated at AED $161 \div 2 =$ AED 80.50. Hence, customer will get cashback of AED 80.50 credited to his/her Credit Card in the next month's Credit Card statement.
 - b. Example 2: Standard movie ticket will cost the customer AED 40.25 (approx.), if customer buys 10 movie tickets then customer has to pay AED $40.25 \times 10 =$ AED 402.50 to the cinema operator). 50% cashback will be calculated at AED $402.50 \div 2 =$ AED 201.25. Hence, customer will get cashback of AED 100.00 credited to his/her Credit Card in the next month's Credit Card statement.
 - c. The offer is not valid on Food & Beverages purchased by the customer.
10. The Offer is available for all days of the week including Weekend and Public Holidays.
11. This Offer is not valid in conjunction with any special promotion run by FH or cinema operators.
12. FH has the right to amend/change/cancel the Offer any time without prior notice to customers.
13. Offer only valid on movie tickets and not on Food and Beverages bought at the Cinema.
14. All purchases of cinema tickets are subject to cinema terms and conditions such as rating and other policies enforced by the participating cinemas.
15. Customer should be Active at the time of crediting the movie cashback offer
